Company has provided the response to notice dated 26.07.2024 by UPMSCL via e-mail dated 05.08.2024. Company has written that they do not agree with both test report of drug batches (batch No.- UP2309031 and UP2309033) provided by UPMSCL empanelled laboratories. Company's response was taken into consideration but not found correct as per tender conditions. As per tender condition (which is already accepted by Company Adroit Pharmaceuticals Pvt. Ltd. in agreement) both drug batches were initially declared "Not of Standard Quality' from UPMSCL empanelled Laboratory then further sent to two other laboratories for confirmation and after evaluation of three test reports from three UPMSCL empanelled laboratories, Drug batches were finally declared "Not of Standard Justifiable.

Reports declared "Not Of Standard Quality" by UPMSCL empanelled laboratories has neither been cancelled nor annulled by any higher authority and therefore the analysis report provided by UPMSCL empanelled laboratories for drug batch no.UP2305086, batch no.-UP2309031 and batch no.
