Biogenetic Drugs Pvt. Ltd has rate contract with UPMSCL for the supply of drug "Ibuprofen 200 mg Tablet". Biogenetic Drugs Pvt. Ltd has supplied drug "Ibuprofen 200 mg Tablet Batch no. 051223-BUP29, 081223-BUP29, 091223-BUP29, 400824-BUP29, 370824-BUP29, 220224-BUP29, 050124-BUP29, 060124-BUP29, 100124-BUP29 and 571124-BUP29 against Purchase order no. UP/UP/HQ/23/2313/1(10282311308), dated 08.12.2023, UP/UP/HQ/24/89/1(10282400742), dated 20.01.2024, UP/UP/HQ/24/1328/1 (10282404987), dated 10.07.2024 and UP/UP/HQ/24/2032/1(10282408347), dated 31.10.2024 to various District Drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd.

Earlier, notice (Ref. No. UPMSCL/MD/QC/2024/505, Dated 27.07.2024) was sent to Biogenetic Drugs Pvt. Ltd for supplying NSQ drug "Ibuprofen 200 mg Tablet, Batch no. 051223-BUP29" on dated 27.07.2024. Batch no. 051223-BUP29" was declared "Not of Standard Quality" by Government Analyst, FDA, UP. Company has provided the representation vide letter dated 01.08.2024 received to UPMSCL on 27.12.2024. Company's response was taken in to consideration but not found correct and justifiable with respect to tender conditions.

Another notice (Ref. No. UPMSCL/MD/QC/2024/577, Dated 09.08.2024) was sent to Biogenetic Drugs Pvt. Ltd for supplying NSQ drug "Ibuprofen 200 mg Tablet, Batch no. 050124-BUP29, batch no. 060124-BUP29 & batch no.100124-BUP29" on dated 09.08.2024. Batch no. 050124-BUP29, batch no. 060124-BUP29 & batch no. 100124-BUP29" were declared "Not of Standard Quality" by UPMSCL empanelled laboratories. Company has provided the representation via email on dated 30.08.2024. UPMSCL reply has been sent to Biogenetic Drugs Pvt. Ltd along with notice dated 30.10.2024 against Company's representation. Company's response was taken in to consideration but not found correct and justifiable with respect to tender conditions.

Another notice (Ref. No. UPMSCL/MD/QC/2024/749, Dated 13.09.2024) was sent to Biogenetic Drugs Pvt. Ltd for supplying NSQ drug "Ibuprofen 200 mg Tablet, Batch no. 081223-BUP29" on dated 13.09.2024. Batch no. 081223-BUP29 was declared "Not of Standard Quality" by Government Analyst, FDA, UP. Company has not provided any response of notice dated 13.09.24 till date.

Another notice (Ref. No. UPMSCL/MD/QC/2024/971, Dated 30.10.2024) was sent to Biogenetic Drugs Pvt. Ltd for supplying NSQ drug "Ibuprofen 200 mg Tablet, batch no. 091223-BUP29" on dated 30.10.2024. Batch no. 091223-BUP29" was declared "Not of Standard Quality" by Government Analyst, FDA, UP. Firm has provided the response vide letter dated 02.11.2024 received to UPMSCL via post on 27.12.2024. UPMSCL reply has been sent to Biogenetic Drugs Pvt. Ltd along with notice dated 14.02.2025 against firm representation. Gompany's response was taken in to consideration but not found correct and justifiable with respect to tender conditions.

Another notice (Ref. No. UPMSCL/MD/QC/2025/1737, Dated 14.02.2025) was sent to Biogenetic Drugs Pvt. Ltd for supplying NSQ drug "Ibuprofen 200 mg Tablet, Batch no.

220224-BUP29" on dated 14.02.2025. Batch no. 220224-BUP29" was declared "Not of Standard Quality" by UPMSCL empanelled laboratory. Company has not provided any response of notice dated 14.02.2025 till date.

Another notice (Ref. No. UPMSCL/MD/QC/2025/306, Dated 23.06.2025) was sent to Biogenetic Drugs Pvt. Ltd for supplying NSQ drug "Ibuprofen 200 mg Tablet, Batch no. 400824-BUP29" on dated 23.06.2025. Batch no. 400824-BUP29" was declared "Not of Standard Quality" by Government Analyst, FDA,UP. Company has not provided any response of notice dated 14.02.2025 till date.

Another notice (Ref. No. UPMSCL/MD/QC/2025/354, Dated 27.06.2025) was sent to Biogenetic Drugs Pvt. Ltd for supplying NSQ drug "Ibuprofen 200 mg Tablet, Batch no. 370824-BUP29" on dated 27.06.2025. Batch no. 370824-BUP29" was declared "Not of Standard Quality" by Government Analyst, FDA, UP. Company has not provided any response of notice dated 14.02.2025 till date.

Another notice (Ref. No. UPMSCL/MD/QC/2025/403, Dated 01.07.2025) was sent to Biogenetic Drugs Pvt. Ltd for supplying NSQ drug "Ibuprofen 200 mg Tablet, Batch no. 571124-BUP29" on dated 01.07.2025. Batch no. 571124-BUP29" was declared "Not of Standard Quality" by UPMSCL empanelled laboratory. Company has not provided any response of notice dated 01.07.2025 till date.

Till date, ten drug batches of drug "Ibuprofen 200 mg Tablet declared "Not of Standard Quality" (Five Drug batches i.e. Batch no. 051223-BUP29, 081223-BUP29, 091223-BUP29, 400824-BUP29 and 370824-BUP29 declared "Not of Standard Quality" from Government Analyst, UPFDA. and Five drug batches i.e. 220224-BUP29, 050124-BUP29, 060124-BUP29, 100124-BUP29 and 571124-BUP29 declared "Not of Standard Quality" from UPMSCL empanelled Laboratories). Test reports of ten "Not of Standard Quality" drug batches have neither been cancelled nor annulled by any higher authority and therefore, the report provided by Government Analyst, UPFDA and UPMSCL empanelled Laboratories remains conclusive report till date.

Thus Company Biogenetic Drugs Pvt. Ltd. has violated the tender (UPMSCL/Drug-192/036 dated-19.05.2023) clause no. **13 (i)** [if two batches of any drug supplied by the supplier is found not of standard quality, then the supplier shall be blacklisted for that particular drug for the period of 03 (Three) Years] by supplying ten "Not of Standard Quality" drug batches (Batch no. 051223-BUP29, 081223-BUP29, 091223-BUP29, 400824-BUP29 and 370824-BUP29, 220224-BUP29, 050124-BUP29, 060124-BUP29, 100124-BUP29 and 571124-BUP29) of drug "Ibuprofen 200 mg Tablet" to different District Drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd.

Hence, the Company Biogenetic Drugs Pvt. Ltd. is, hereby, blacklisted for the drug "Ibuprofen 200 mg Tablet" for three years from the date of issue of this order.
