Bioconic Remedies has rate contract with UPMSCL for the supply of drug "Calcium Vitamin D3 Suspension (Each 5ml contains Calcium Carbonate eq. to Elemental Calcium 250mg+Vitamin D3 -125 IU), 200 ml Bottle". Bioconic Remedies has supplied drug "Calcium Vitamin D3 Suspension (Each 5ml contains Calcium Carbonate eq. to Elemental Calcium 250mg+Vitamin D3 -125 IU), 200 ml Bottle, Batch no. BRUPL028, BRUPL029, BRUPL032, BRUPL033, BRUPL035, against purchase order no. UP/UP/HQ/23/2379/3 (10282311679) dated 22.12.2023, Batch no. BRUPL058, BRUPL063 against purchase order no. UP/UP/HQ/24/213/3 (10282401297) dated 25.02.2024, Batch no. BRUPL175, BRUPL177, BRUPL179, BRUPL182, BRUPL183, BRUPL189, BRUPL191, BRUPL192 & BRUPL194 against purchase order no. UP/UP/HQ/24/1251/2(10282404567) dated 02.07.2024 to various District Drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd.

Earlier, notice (Ref. No. UPMSCL/MD/QC/2024/797, Dated 25.09.2024) was sent to Bioconic Remedies for supplying of NSQ drug "Calcium Vitamin D3 Suspension (Each 5ml contains Calcium Carbonate eq. to Elemental Calcium 250mg+Vitamin D3 -125 IU), 200 ml Bottle), batch no. BRUPL063" on dated 25.09.2024. Firm has provided the response vide letter ref. no. Nil, dated 19.11.2024 received to UPMSCL on 26.11.2024. UPMSCL reply has been sent to Company with notice (Ref. No. UPMSCL/MD/QC/2024/1517, Dated 03.01.2025) against representation given by Bioconic Remedies. Firm's representation was taken in to consideration but not found correct and justifiable with reference to tender conditions.

Another Notice (Ref. No. UPMSCL/MD/QC/2025/1517, Dated 03.01.2025) was sent to Bioconic Remedies for supplying of NSQ drug "Calcium Vitamin D3 Suspension (Each 5ml contains Calcium Carbonate eq. to Elemental Calcium 250mg+Vitamin D3 -125 IU), 200 ml Bottle), batch no. BRUPL028, BRUPL029, BRUPL032, BRUPL033, BRUPL035, BRUPL058, BRUPL179 & BRUPL191 on dated 03.01.2025. Firm has not provided any response to notice dated 03.01.25 by UPMSCL till date.

Another Notice (Ref. No. UPMSCL/MD/QC/2025/1847, Dated 05.03.2025) was sent to Bioconic Remedies for supplying of NSQ drug "Calcium Vitamin D3 Suspension (Each 5ml contains Calcium Carbonate eq. to Elemental Calcium 250mg+Vitamin D3 -125 IU), 200 ml Bottle), batch no. BRUPL175, BRUPL177, BRUPL182, BRUPL183, BRUPL189, BRUPL192 & BRUPL194" on dated 05.03.2025. Firm has not provided any response to notice dated 05.03.25 by UPMSCL till date.

Till date, Sixteen drug batches of drug "Calcium Vitamin D3 Suspension (Each 5ml contains Calcium Carbonate eq. to Elemental Calcium 250mg+Vitamin D3 -125 IU), 200 ml Bottle" declared "Not of Standard Quality" (All 16 drug batches declared "Not of Standard Quality" from UPMSCL empanelled Laboratories. Test reports of sixteen "Not of Standard Quality" drug batches have neither been cancelled nor annulled by any higher authority and

therefore, the report provided by UPMSCL empanelled Laboratories remains conclusive report till date.

Thus Firm Bioconic Remedies has violated the tender (UPMSCL/Drug-192/036 dated-19.05.2023) clause no. **13 (i)** [if two batches of any drug supplied by the supplier is found not of standard quality, then the supplier shall be blacklisted for that particular drug for the period of 03 (Three) Years] by supplying Sixteen "Not of Standard Quality" drug batches (Batch no. BRUPL028, BRUPL029, BRUPL032, BRUPL033, BRUPL035, BRUPL058, BRUPL063, BRUPL175, BRUPL177, BRUPL179, BRUPL182, BRUPL183, BRUPL189, BRUPL191, BRUPL192 & BRUPL194 of drug "Calcium Vitamin D3 Suspension (Each 5ml contains Calcium Carbonate eq. to Elemental Calcium 250mg+Vitamin D3 -125 IU), 200 ml Bottle" to different District Drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd.

Hence, Firm Bioconic Remedies is, hereby, blacklisted for the drug "Calcium Vitamin D3 Suspension (Each 5ml contains Calcium Carbonate eq. to Elemental Calcium 250mg+Vitamin D3 -125 IU), 200 ml Bottle" for three years from the date of issue of this order.
