#### Office Order

Affy Parentrals has rate contract with UPMSCL for the supply of drug "Calcium Carbonate with Vitamin D3: 1250 mg +250 IU (Tab)". Affy Parentrals has supplied drug "Calcium Carbonate with Vitamin D3: 1250 mg+250 IU (Tab), Batch no.- PGT24013 (Mfg. Date 04/24, Exp. Date 03/26) against Purchase order no. UP/ UP/ HQ/ 24/137/1 (10282400864) dated 31.01.2024, batch no. PGT24059 (Mfg. date 04/2024, Exp. date 03/2026) against purchase order no. UP/UP/HQ/24/137/1 (10282400864), dated 31.01.2024 and batch no. PGT241158 (Mfg. date 12/24, Exp. Date 11/26) against purchase order no. UP/UP/HQ/24/1990/1 (10282408183), dated 30.10.2024 and batch no. PGT241139 (Mfg. Date 12/2024, Exp. Date 11/2026) against purchase order no. UP/UP/HQ/24/1824/1 (10282407256), dated 02.10.2024 to various District Drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd.

Earlier, a notice (Ref. No. UPMSCL/MD/QC/2024/1308, dated 28.11.2024) was sent to Affy Parentrals regarding supply of "Not of Standard Quality" drug "Calcium Carbonate with Vitamin D3: 1250mg+250IU (Tab), batch no. PGT24013" on dated 28.11.2024. Batch no. PGT24013 was declared "Not of Standard Quality" from UPFDA Government Analyst of Gorakhpur. Firm has not provided response to notice by UPMSCL dated 28.11.2024

Another notice (Ref. No. UPMSCL/MD/QC/2025/544, dated 21.07.2025) was sent to Affy Parentrals regarding supply of "Not of Standard Quality" (NSQ) drug "Calcium Carbonate With Vitamin D3: 1250 mg+250 IU (Tab), batch no. PGT24059 & batch no. PGT241158" on dated 21.07.2025. Batch no. PGT24059 was declared NSQ from UPFDA Govt. Analyst, Agra and batch no. PGT241158 was declared NSQ from UPFDA Govt. Analyst, Lucknow)

Another notice (Ref. No. UPMSCL/MD/QC/2025/552, dated 23.07.2025) was sent to Affy Parentrals regarding supply of "Not of Standard Quality" drug "Calcium Carbonate with Vitamin D3: 1250 mg+250 IU (Tab), batch no. PGT241139" on dated 23.07.2025. Batch no. PGT241139 was declared NSQ from UPMSCL empanelled laboratories.

Firm has provided response (Letter dated 26.07.2025) to notice dated 21.07.2025 (Ref. No. UPMSCL/MD/QC/2024/544) by UPMSCL which was received to UPMSCL on 05.08.2025. In the response Firm has stated that they have not received any letter, test report and sample portion from respective Drug Inspector till date. Firm has written that they will challenge the Government Analyst report of batch no. PGT24059, PGT241158 and PGT24013 as per Drug and Cosmetic Act 1940 and rules thereunder i.e. section 23(4), 25(3) & 25(4) but till date Firm has not provided any conclusive evidence of challenging the Govt. analyst report of Drug batch no. PGT24059, PGT241158 and PGT24013. As the report provided by govt. analyst is neither annulled nor cancelled by any higher authority hence the report provided by Government analyst remains conclusive evidence till date and all action shall be taken as per tender condition.

Firm has also provided response (Letter dated 28.07.2025 ) to notice dated 23.07.2025 (Ref. No. UPMSCL/MD/QC/2024/552 ) by UPMSCL which was received to UPMSCL on 05.08.2025. In the response Firm has stated that they do not agree with the test reports of batch no. PGT241139 provided by UPMSCL empanelled laboratories and challenge the report.

Firm's representation dated 26.07.25 and 28.07.2025 were taken in to consideration but not found correct and justifiable with reference to tender conditions. Till date, four drug batches of drug "Calcium Carbonate With Vitamin D3: 1250 mg +250 IU (Tab)" were declared "Not of Standard Quality" (01 drug batch was declared "Not of Standard Quality" from UPMSCL empanelled Laboratories and 03 drug batches were declared "Not of standard quality" from UPFDA Government Laboratories. Test reports of four "Not of Standard Quality" drug batches have neither been cancelled nor annulled by any higher authority and therefore, the report provided by UPMSCL empanelled Laboratories and Government Laboratory remains conclusive report till date.

Apart from above, Firm Affy Parentrals has also violated the tender (UPMSCL/Drug-192/036 dated-19.05.2023) clause no. 13 (i) [ if two batches of any drug supplied by the supplier is found not of standard quality, then the supplier shall be blacklisted for that particular drug for the period of 03 (Three) years ] by supplying Four "Not of Standard Quality" drug batches ( Batch no. PGT24013, PGT24059, PGT241158 and PGT241139 drug "Calcium Carbonate With Vitamin D3: 1250 mg +250 IU (Tab)" to different District Drug warehouses of Uttar Pradesh Medical Supplies Corporation Ltd.

Hence, Firm Affy Parentrals is, hereby, blacklisted for the drug "Calcium Carbonate With Vitamin D3: 1250 mg +250 IU (Tab)" for three years from the date of issue of this order.
